In order to ensure secure identification, the legislator has approved only those means of identification from the member states of the European Union that meet the assurance level "high" as defined in the eIDAS-regulation. Please note that further identification documents are constantly being approved. This may mean that other ID documents not yet listed above can still be used for an online procedure.
